I.R.E. means Institutions for sheltered housing and Education. For the Italian law IRE is a no profit, public institution which is in charge, for the venetian territory, of the assistance of elders and disabled people. IRE is not a cultural institution, but has its own Artistic and Historical Bureau, which is in charge of the preservation and conservation of all the IRE historical monuments, sites, documents and fine arts that had been gathered by donation during its history dating from XVI century.

Among these "treasures" there is the Tomaso Filippi photographic archive, a donation from the last surviving daughter of the venetian photographer who for many years until her death was a guest of one of IRE old folks home.

For IRE Artistic and Historical Bureau one of the way to collect money for its cultural activities (publications, restorations, cataloguing, concerts and more), are the licence fees for the reproduction of its artistic heritage.

Publications granted of free reproduction charge will also acknowledge the gratitude to I.R.E. for making the images available.

If captions are envisaged please check them with I.R.E. in advance. In any case the caption should mention the Author/the Archive name, the title/subject, the place where the photo had been taken, the dating period, the technique and the measures. Omission of credit line will authorise I.R.E. to bill 100% additional fee to the agreed cost of single picture.

► The client undertakes to send at least one copy of the publication, or the relevant sheets showing the products or publications in which pictures were used. In case of publications free reproduction charge for a work of relevant significance for Filippi's renown, I.R.E is allowed to ask a few free copies of it.

Every single image can be used only once and for one product only (one edition in one language). For further uses and other editions a new authorization form must be requested. For any reprints or editions with the same Publisher the price is 50% off above the initial cost.

► Internet publications are to be intended as "international distribution use"

► It is clear that pictures cannot be cut, cropped or manipulated in any way. No copy, no lending, no personal use is allowed in any form. Once printed, is prohibited to reuse or distribute the images without I.R.E authorisation.

► If a client paid no reproduction charge but might eventually publish his work, he must ask IRE for a new permission before publication.

► I.R.E. reserves itself the right to decide case by case the amount of the image reproduction charge. Special agreements could be drawn up with the Client in case his work project might be an occasion for promotion of I.R.E. artistic and historical heritage.
